## **NSTAR Electric Company Declares Preferred Dividends**

**BOSTON** (June 22, 2016) – The Board of Directors of NSTAR Electric Company, a wholly-owned subsidiary of Eversource Energy, announced the declaration of the following preferred stock dividends payable August 1, 2016 to holders of record as of July 8, 2016:

- A quarterly dividend of \$1.0625 per share on NSTAR Electric Company's cumulative preferred stock,
  4.25% series; and
- A quarterly dividend of \$1.195 per share on NSTAR Electric Company's cumulative preferred stock, 4.78% series.
